Inserted advertisements will be billed monthly. Advertiser will be liable for payment for all agreed-upon insertions, notwithstanding actual insertion status (unless non-insertion is the fault of the Record, in which case only the affected insertion will be excused from payment). Rate differences incurred as a result of unused contracted insertions in any discount category will be billed in September, 2018, or at contract termination. Additional requested insertions may require a separate signed contract.

Materials deadlines and single-insertion deadlines are 7 days prior to the publication date. Space reservations should be made as far in advance as possible.

The advertiser shall indemnify and hold harmless the Regents of U-M, its agents and employees, from and against any and all actions, claims, liabilities, demands, damages, costs and expenses, including court costs and attorney fees from the publication in the Record of advertising material furnished by the advertiser.
